01-07-25/03 MINUTES OF THE MEETING HELD ON 6th May 2025

RESOLVED - That the minutes of the meeting held on 6th May 2025 are confirmed as a

true record and signed by the Chairman.

01-07-25/04 UPDATES FROM MINUTES OF 6th May 2025

RESOLVED – Clerk previously raised the issue with Highways of the damaged grills in School Lane. Highways confirmed they have scheduled the work to take place in Spring. Councillors asked Clerk to follow this up as it needs doing in the drier months. The home to school transportation issue is still unresolved. Clerk read out the brief email update from AT. He shared his concerns that Richmond school is full which means students from his constituency may not be able to get a place at the school. In respect of the new transport policy, he said he didn't like it any more than anyone else. Had the motion before full council on 19th May succeeded and reverted to the catchment system, and which he voted against, then we would almost certainly have had to put forward cuts in frontline services. SEND or special educational needs could have been one. Is that what people want? Of course not. We all want more funding from central government. But it has been made absolutely clear that that won't be forthcoming. Indeed, sadly the vibes are that even more cuts to funding for councils like North Yorkshire are forthcoming. He also said: Please understand that without further funding, by year 28/29 it is very unlikely that anyone in North Yorkshire will get free school transport. AT did share that he is supporting an initiative brought forward by Sharon Diamond, a resident of Eppleby. This is looking at tweaking the current public bus timetable managed by Hodgsons. Students from villages like Stapleton, Manfield, Eppleby, Aldbrough and Melsonby will be able to travel to Richmond School for £1 per journey which, with full attendance throughout the academic year would be about £390.

AA has corresponded with AT since the last meeting and in response to AT's vote to support the new policy. Councillors feel unsupported in the issues raised. AA confirmed that there is still an issue of children in Eppleby village being allocated 3 different schools

under the home to school transportation policy. The school allocated is dependent on where they live in the village. This needs to be one school allocated to all children of Eppleby. This was raised at the November meeting, this was the last meeting AT attended. The work to carry out remedial/repair work on the benches was delayed as the wrong benches were delivered and left on the village green. JN Bentleys are looking into this. Clerk followed up on the other issues previously raised and to be completed by JN Bentleys. AA confirmed that damaged verges have been repaired. Councillors did agree that they will except any benches that donated by JN Bentleys and will then look at what is still required and if it can be funded by the Parish Council.

AA asked that the item to replace the goal posts is reviewed at the next meeting. Clerk confirmed that the installation meeting for the outdoor gym equipment was arranged for 2nd July. AS, Mary Imray and Clerk will attend the meeting and agree the placement of the equipment. AS said that there is an area near the entrance of the play park that may need to be avoided. He will raise this at the meeting. The installation will take place end of August/beginning of September. The vegetation growth on the footpath still needs cleaning. Clerk has contacted Street Scene at NYC.

No update had been received from Steve Barker at Highways on the various issues raised with flooding, blocked gullies, and drainage around the village. Clerk will follow this up again. AA did mention no date has been agreed to carrying out the dye testing. There was flooding at New Road, this was from the old gulley/bus stop to the new gulley. Clerk will raise this. AS suggested that the noticeboards are refreshed. It was agreed to monitor the existing boards and mark as completed. A resident of Chapel Row mentioned flooding issues. AA has asked the resident to forward him a copy of the correspondence. As yet, nothing had received. Councillors discussed that they had spoken about this issue years previously and options had given to the residents to either re do their drainage and connect into a possible soakaway (they could build on the village green) or possibly discuss with Highways about connecting to the drains. This was not taken any further. AA reiterated that the Parish Council will be as supportive as they can. The residents involved would need to agree a plan and move this forward.

Providing school children transport to and from school and residents access to a service that benefits everyone. The route is under review by NYC and Sharon has asked that the Parish Council support the changes. Councillors unanimously agreed to support it. Clerk will write to AT and the Mayor of York. Residents raised the issue of parking around the village. Was adequate consideration given for parking, some of the village green is used. AA agreed that parking is limited. Household's now have more than two cars; this has increased over time. It is something the Parish Council can't 'police' but do ask that residents are considerate of others and where they park. Ensuring minimum damage to the verges and village green.
