07-03/04 UPDATES FROM MINUTES OF 10th January 2023

> The Clerk continues to follow up on existing issues raised with Highways. The Parish Council have received a response on the flood damage to footpath surface. The case has been closed as the damage does not meet the criteria to need repair. Highways have confirmed they will monitor the issue regarding the Caldwell to A66 road condition.

The main Eppleby road sign has been damaged by a tractor. AA has instructed a AA

contractor to repoint the brick work. This is in hand.

Clerk has instructed NYCC and SWARCO to install the pole and matrix board. The pole has been installed but the VAS is still to be installed. Clerk will follow up with SWARCO to get an installation date. Yorkshire Water have looked at the perished manhole cover on the green. They have confirmed that it does not meet the criteria to be replaced. The garage vacancy was advertised, a number of applicants were received and considered for the vacancy. A unanimous decision was made, Clerk to

inform all applicants of the outcome. The Parish Council have applied for £174 for

funding to support the King's Coronation celebrations.

REPORT FROM DISTRICT AND COUNTY COUNCILLORS

RESOLVED – County Councillor Angus Thompson gave an update on the unitary authority. The new authority will start on 1st April 2023 and will be called North Yorkshire Council. Angus confirmed that after the 1st April you should use exactly the same email address or telephone number as at present. Email addresses will no doubt be updated in due course and this is certainly the best form of contact. Council tax has been increased by 2.99%. Litter continues to be an annoying problem in the region and indeed nationally. Amanda Dyson's team at Richmond will continue as normal after 1st April, being responsible for litter picking and clearing the mess after fly tipping within Richmondshire. Angus suggested that Highways signs like they do in County Durham should be used to deter this. They can be moved around as necessary and could be funded from the Locality Budget hence putting no further strain on hard pressed finances. AA asked about small business rates relief and whether this will continue. Angus suspected it will continue but could not confirm this. AA asked about domestic council tax on unoccupied property and if this will be reviewed. Angus said this is a national approach and will remain in place.
